

## **Objectives:**

The project will advance knowledge of migration and resilience in three main ways. First, empirical evidence collected to complement our multiscale comparative policy discourse analysis will provide in-depth understanding of the informal dynamics of policy making and governmentality. Second, we will offer a unique and important comparison between key informants' views from three levels of government and between two provinces, which have varying discursive agendas and strategies. Last, our analysis will further the discussion around the adoption of state discourses on “immigrant resilience,” thus bringing new insights into the complex nature of the concept and its policy implications.

### How will this project be implemented in practice?

We will conduct in-depth semi-structured key informant interviews with 1-2 representatives at the three levels of government (federal, provincial, municipal):

- Federal: 2 key informant interviews (completed)
- Province of Ontario: 2 key informant interviews (completed)
- Province of Quebec: 2 key informant interviews (TBD)
- City of Toronto: 2 key informant interviews (completed)
- City of Montreal: 2 key informant interviews (TBD)
- City of Ottawa: 1 key informant interviews (completed)
- City of Gatineau: 1 key informant interviews (completed)
- Waterloo-Region: 1 key informant interviews (TBD)
- Kitchener: 1 key informant interviews (TBD)
- Waterloo: 1 key informant interviews (TBD)

The interview guide was prepared collaboratively by the research teams in Ottawa-Gatineau, Toronto, and Kitchener-Waterloo. REB approval was obtained at uOttawa, U of T, and WLU.

Research teams in Ottawa-Gatineau and Toronto completed data collection in summer 2019.

The research team in Kitchener-Waterloo will consult with other city-network researchers to coordinate interviews. Interviews will be conducted in summer-fall 2020.

In-depth analysis remains to be completed.
